The health hazards listed below are for components to this mixture. The active ingredients are diluted in water in this mixture and the severity of the listed health hazards for this product may be reduced. Signs And Symptoms of Exposure -

Signs and symptoms of exposure to potassium hydroxide through breathing, swallowing, and/or passage through the skin may include: cough, lung edema (fluid buildup in the lung tissue).

Medical Conditions Generally Aggravated By Exposure - May aggravate existing dermatitis. Pre-existing skin disorders may be aggravated by exposure.
